INVITATION TO BID

Notice is Hereby Given that sealed bids will be received by the Village Clerk of the Village of Tuxedo Park until 2:00 p.m. at the prevailing time standard on **Friday, February 12, 2016** at the Village Office, 80 Lorillard Rd., Tuxedo Park, New York, 10987 and will be publicly opened and read aloud at that time.

Bids shall be made upon the forms provided in accordance with the instruction to bidders. Bids shall be submitted in a sealed envelope marked:

“SSES Phase 3 Sub-Basins 2 & 10 Public Sanitary Sewer Repairs”

The work to be performed includes but is not limited to the removal and disposal of two (2) existing manholes, installation of two (2) precast concrete sanitary sewer manholes with frames and covers, sealing and cementitious lining of ten (10) sanitary sewer manholes, installation of approximately 1,900 LF of 6” Cured-in-Place Pipe (CIPP) with associated television inspection, cleaning, chemical root treatment, bypass pumping, and service reinstatement as necessary. The work will take place in the Continental Road, Circuit Road, and Clubhouse Road regions of the Village of Tuxedo Park’s sanitary sewer system.

Copies of the Contract Documents will be available beginning Monday, January 11, 2016 between the hours of 10:00 a.m. and 4:00 p.m. at the office of the Village Clerk, Village of Tuxedo Park, 80 Lorillard Rd., Tuxedo Park, New York, 10987. A fifty dollar (\$50.00) cash deposit is required for each set of bid documents requested. If the contractor submits a bid, the deposit will be refunded for each complete original bid set returned as originally bound, unmarked and in good condition. If a bid is not submitted, twenty-five (\$25.00) dollars will be refunded for each complete original bid set returned as originally bound, unmarked and in good condition. No refund will be made on Contract Drawings and Specifications returned later than forty days after bids have been received.

As a bid security, each proposal shall be accompanied by a certified check or bid bond in the amount of ten percent (10%) of the total amount of the base bid. The bidder to whom a contract is awarded will be required to furnish performance and payment bonds from an acceptable surety company in the total amount of the contract.

A pre-bid meeting and site walk (weather permitting) will be held at the Village Office on Wednesday, January 20, 2016 at 10:00 am.

The Village of Tuxedo Park reserves the right to reject any or all bids at its sole discretion and to accept the bid which it considers to be in the best interest of the Village of Tuxedo Park.
